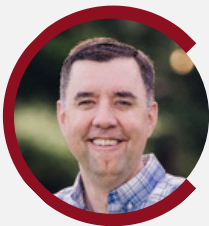




# Alabama

Incumbent Alabama Attorney General Steve Marshall is term limited for the 2026 election.

Below are the candidates:



**Jay Mitchell (R)**

Jay Mitchell currently serves as a justice on the Alabama Supreme Court. He earned his law degree from the University of Virginia School of Law, and earned his B.A. with honors at Birmingham-Southern College. Before his election to the Supreme Court in 2018 he worked in private practice..



**Katherine Robertson (R)**

Katherine Robertson is chief counsel to Alabama Attorney General Steve Marshall. Prior to joining the attorney general's office, Katherine served as clerk and counsel to Senator Jeff Sessions on the U.S. Senate Judiciary Committee. She also served as vice president of the Alabama Policy Institute. She is a graduate of Auburn University and the University of Alabama School of Law.



**Jeffrey McLaughlin (D)**

Jeffrey McLaughlin is an attorney in private practice, and previously served in the Alabama House of Representatives. He is a graduate of Birmingham-Southern College and earned his J.D. from Harvard Law School.

# Arizona

**Incumbent Arizona Attorney General Kris Mayes is running for reelection in 2026.**



**Kris Mayes (D)**

Kris Mayes was elected as the 27th Arizona Attorney General in the 2022 general election. Prior to being elected, AG Mayes served as a professor at Arizona State University's School of Global Sustainability and taught a course on energy law at the school's Sandra Day O'Connor College of Law. In 2003 she was appointed to the Arizona Corporation Commission and served until term-limited in 2010. Early in her career, she served as director of communications for former Gov. Janet Napolitano and as a journalist with The Phoenix Gazette and The Arizona Republic.

**Rodney Glassman (R)**

Rodney Glassman serves as a lieutenant colonel in the United States Air Force JAG Corps Reserve. He is a former Tucson City Council member and acting town manager of Cave Creek, Arizona. Before earning his J.D. at the University of Arizona, he earned a PhD in arid land resource sciences and his bachelor's in agricultural economics.



**Warren Petersen (R)**

Warren Petersen, currently serves as Arizona State Senate president and owns a real estate brokerage. He has held leadership roles including house majority leader and chaired key committees such as Rules, Commerce, and Judiciary. He received his bachelor's degree from Arizona State University and a J.D. from ASU Law.

# Arkansas

**Incumbent Arkansas Attorney General Tim Griffin is running for reelection in 2026.**



**Tim Griffin (R)**

Tim Griffin was elected to be Arkansas's 57th attorney general in November 2022. AG Griffin served as Lieutenant Governor of Arkansas from 2014 to 2022. Prior to that, AG Griffin represented Arkansas's 2nd U.S. Congressional District from 2011 to 2015. From 2006 to 2007, AG Griffin served as U.S. Attorney for the Eastern District of Arkansas, and he previously served as special assistant to the president and deputy director of political affairs for President George W. Bush. AG Griffin is a Colonel in the Arkansas Army National Guard and served as an officer in the U.S. Army Reserve Judge Advocate General's (JAG) Corps. AG Griffin earned his B.A. from Hendrix College and his J.D. from Tulane University

# California

**Incumbent California Attorney General Rob Bonta is running for reelection in 2026.**



**Rob Bonta (D)**

Rob Bonta was appointed to serve as California Attorney General in March 2021 to replace former AG Xavier Becerra when he was confirmed as the head of the U.S. Department of Health and Human Services. He was elected to a full term in 2022. For almost a decade, AG Bonta has represented areas of Alameda County in the State Assembly, and was the first Filipino-American elected to California's legislature. Before joining the legislature he was a deputy city attorney in San Francisco and a member of the Alameda City Council. AG Bonta earned his B.A. and J.D. from Yale University.

**Michael Gates (R)**

Michael Gates began his career as a litigator and trial lawyer before serving ten years as the elected city attorney of Huntington Beach, where he oversaw major litigation and launched the city's first local Criminal Prosecutor Program. In 2025, he was appointed deputy assistant attorney general in the U.S. Department of Justice's Civil Rights Division. He graduated from Pepperdine University and earned his J.D. from Chapman University.

# Colorado

**Incumbent Colorado Attorney General Phil Weiser is term limited for the 2026 election. He is running for governor.**

**Below are the candidates:**



**Michael Dougherty (D)**

In 2010, Michael Dougherty joined the Colorado Attorney General's Office to lead the DNA Justice Project and was thereafter appointed deputy AG. He later served as assistant district attorney for Jefferson and Gilpin counties. Since 2018, he has been the elected district attorney for Colorado's 20th Judicial District. He is a past president of the District Attorneys of Colorado. After graduating from Nassau Community College, he attended Cornell University and the Boston University School of Law.



**Hetal Doshi (D)**

Hetal Doshi served as an assistant U.S. Attorney in the District of Colorado, prosecuting fraud, corruption, and other serious crimes, and later as deputy assistant attorney general for the Antitrust Division. She studied political science at Emory University and earned a J.D. from the University of Virginia School of Law.



**Jena Griswold (D)**

Jena Griswold began her career practicing international anti-corruption law in Washington, D.C., then served as director of the governor of Colorado's D.C. Office. In 2018, she was elected Colorado's 39th Secretary of State and was reelected in 2022. She attended Whitman College and the University of Pennsylvania Carey Law School.



**David Seligman (D)**

David Seligman is the executive director of Towards Justice, a nationally recognized nonprofit focused on labor and consumer rights. Previously, he was an attorney at the National Consumer Law Center. He is a graduate of Williams College and Harvard Law School.



**Michael Allen (R)**

Michael Allen is the district attorney for Colorado's 4th Judicial District, a role he has held since 2021. A U.S. Navy veteran, he began his legal career in the Kansas Attorney General's Office before serving as a prosecutor in two Colorado counties. He attended the University of Northern Colorado and the University of Kansas School of Law.

# Connecticut

**Incumbent Connecticut Attorney General William Tong is running for reelection in 2026.**



**William Tong (D)**

William Tong was elected in 2018 as the first Asian-American to serve at the statewide level in Connecticut, and was reelected in 2022. Prior to his election, AG Tong served 12 years in Connecticut's General Assembly representing the 147th district, including serving as House Chairman of the Judiciary Committee. For 18 years, he practiced as a litigator in both state and federal courts first at Simpson Thacher & Bartlett in New York City and then at Finn Dixon & Herling in Stamford, CT. AG Tong was reelected in 2022. AG Tong earned his B.A. at Brown University and his J.D. from the University of Chicago.

# Delaware

**Incumbent Delaware Attorney General Kathy Jennings is running for reelection in 2026.**



**Kathy Jennings (D)**

Kathy Jennings was elected as attorney general in 2018 and reelected in 2022. Prior to her election, she was chief administrative officer of New Castle County. AG Jennings previously served as chief deputy AG under former AG Charles Oberly, where she helped create Delaware's Consumer Fraud Division. Following AG Jennings' tenure as chief deputy, she and Oberly entered private practice together. AG Jennings also served as state prosecutor, and was a prosecutor for the Delaware Department of Justice. She is a graduate of the University of Delaware and earned her J.D. from Villanova University.

**Dwayne Bensing (D)**

Dwayne Bensing is a civil rights attorney who currently serves as legal director of the ACLU of Delaware, a role he assumed in 2022 after joining the organization in 2020. His prior experience includes serving as a trial attorney in the U.S. Department of Justice's Civil Rights Division and in the U.S. Department of Education's Office for Civil Rights. He began his legal career at Fried, Frank, Harris, Shriver & Jacobson LLP in Washington, D.C., after earning his law degree from the University of Pennsylvania.

**Incumbent D.C. Attorney General Brian Schwalb is running for reelection in 2026.**



**Brian Schwalb (D)**

Brian Schwalb was sworn in as the second elected District of Columbia Attorney General in January 2023. Prior to being elected, AG Schwalb served as the partner-in-charge of the DC office of Venable LLP, and previously served as vice chairman of the firm. Early in his career he worked for the U.S. Department of Justice's Honor Program as a trial lawyer in the Tax Division. AG Schwalb earned his B.A. from Duke University and his J.D. from Harvard Law School.

# Florida

**Incumbent Florida Attorney General James Uthmeier is running for reelection in 2026.**



**James Uthmeier (R)**

James Uthmeier was named as Florida's Attorney General by Governor Ron DeSantis in 2025 to fill the vacancy left when former AG Ashley Moody was appointed by the governor to the U.S. Senate. Prior to his appointment, AG Uthmeier served as Governor DeSantis' chief of staff and general counsel. He began his tenure in the governor's office in 2019 as deputy general counsel and was promoted to general counsel the following year. After law school, he worked in Washington D.C., where he interned as a law clerk in then-Senator Marco Rubio's office. He also worked as an associate in private practice before joining the Trump administration in 2017, where he served as a senior adviser to then-Commerce Secretary Wilbur Ross. AG Uthmeier received his undergraduate degree from the University of Florida and his J.D. from Georgetown University.

Steven Leskovich currently serves as a public official and interim city attorney of Punta Gorda. Jim Lewis is a Fort Lauderdale criminal defense attorney and longtime prosecutor. In 2001, AG Kobach received a White House Fellowship from President George W. Bush, and he went on to serve in the United States Department of Justice under Attorney General John Ashcroft as counsel to the attorney general. Early in his career, AG Kobach clerked for the Tenth Circuit Court of Appeals, and shortly thereafter became a professor of constitutional law at the University of Missouri-Kansas City School of Law. AG Kobach earned his B.A. from Harvard University, a Doctor of Philosophy from the University of Oxford, and his J.D. from Yale University.

Adriana Guzmán Fralick is an attorney in private practice, and previously served as general counsel to the governor, executive secretary to the Nevada Gaming Control Board and Gaming Commission, and chief deputy district attorney for Carson City. AG Wrigley served out the remainder of AG Stenehjem's term, following AG Stenehjem's unexpected death on January 28, 2022, and was elected to a full term in November 2022. AG Wrigley is a fourth generation North Dakotan and former U.S. attorney and lieutenant governor. 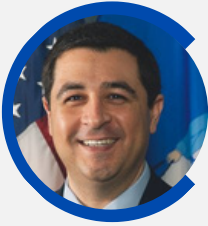
